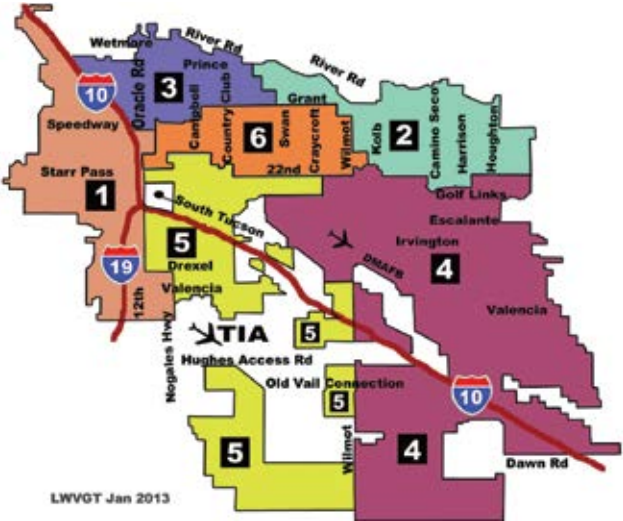

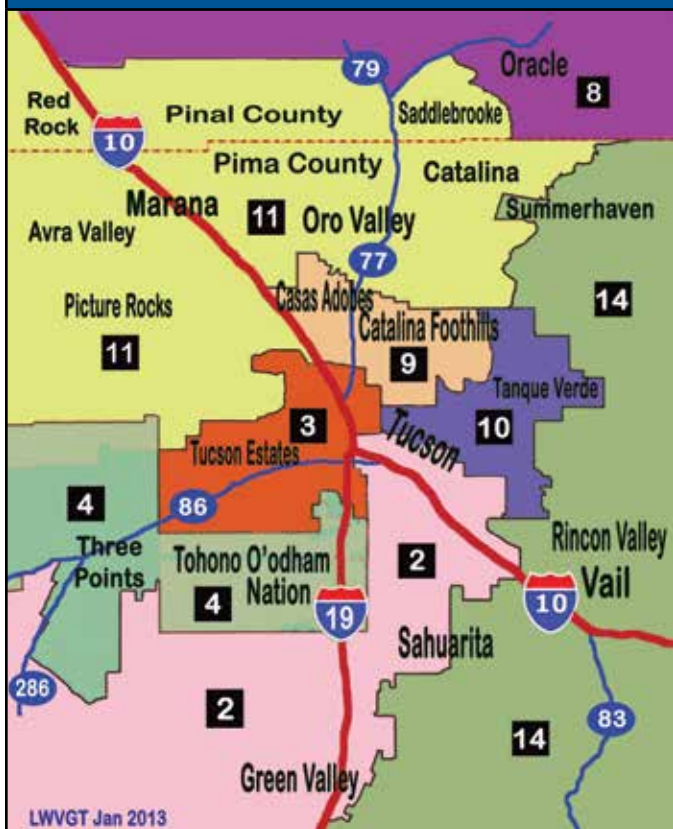
**ARIZONA STATE COURTS**

Judges of the Supreme Court, the Court of Appeals, and of the Superior Court in Maricopa, Pima, and Pinal counties are appointed to office by the governor upon recommendation of a bipartisan commission. The term of office of a Supreme or an Appellate Court judge is six years and of a Superior Court judge four years. At the expiration of their terms, appointed judges wishing to remain in office have their names placed upon the ballot. The electorate then votes to retain or reject them. The Clerk of the Pima County Superior Court is an elective office with a 4-year term.

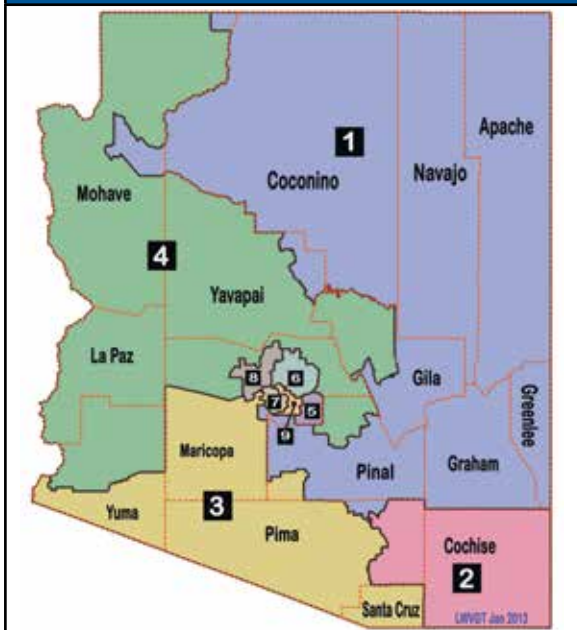

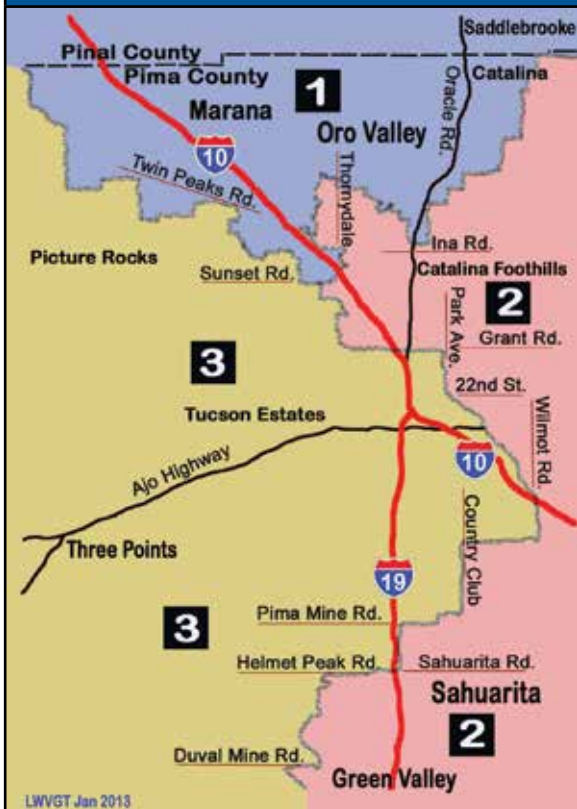

## VOTING INFORMATION

### Proof of who you are and where you live required for Primary and General Elections

#### THREE WAYS YOU CAN VOTE

- 1. In Person:** Vote at the polls: Your name must be on the poll roster and you must present the proper ID\*
- 2. By Mail:** Vote from home with an early ballot - recorder.pima.gov, Early Ballot Request under Voter Services
- 3. In Person with an early ballot:** Vote at any early voting site - recorder.pima.gov, under Voter Services

#### \*PROPER ID FOR VOTING ON ELECTION DAY

##### **Type I- Photo ID**

Acceptable forms of identification include any one of the following:

- An Arizona driver's license
- An identification card issued by the Arizona Motor Vehicle Division
- A tribal enrollment card
- Other forms of tribal identification.
- Other identification issued by the federal, state or local government.

*Remember, Type I identification must have your photograph, your name and your current address and this information must reasonably match the information in the poll roster.*

##### **Type II-Non-Photo ID**

In order to vote using type two identification, you must present **two different forms** of identification from the list below:

- A utility bill
- A bank or credit union statement (if dated within 90 days)
- A valid Arizona vehicle registration
- An Indian census card
- A tribal enrollment card
- Other forms of tribal identification
- A property tax statement
- An Arizona vehicle insurance card
- A Recorder's certificate
- A voter registration card
- A valid federal, state or local government issued identification card
- Any mail addressed to you that includes the "Official Election Material" logo

*Remember, Type II identification must contain your name and current residence address and that information must reasonably match the information in the poll roster. You must also have two different items from the list.*

##### **Type III-Photo ID with invalid address and other identification III**

If you have a form of photographic identification that is listed under Type I above, but the address does not match the poll roster, you may combine that information with one of the valid forms of identification listed under Type II. Valid military identification or a United States passport may also be combined with one of the forms of identification listed under Type II.

*Any expired piece of identification is not valid*

#### FOR INDEPENDENT VOTERS

**Primary Elections:** Voters registered as "Independent" or "No Party Preference" may choose to vote in a primary but they may only vote one party's ballot and must indicate for each primary which party they select. This does not change their "Independent Voter" status.

**General Elections:** Everyone votes the same ballot, so voters do not have to request a particular party ballot.

\*You must provide proof of citizenship if you are registering for the first time in Arizona or you move to/from another county in Arizona, or if you are re-registering after being in a cancelled status.

#### Who is eligible to vote in Pima County?

- You are a United States Citizen.
- You are 18 or older, or will be 18 by the next General Election.
- You live within Pima County at least 29 days prior to the General Election.
- You have not been convicted of a felony or treason, or if you have, your rights have been restored.
- You have not been adjudicated an incapacitated person or not under mental health guardianship.

#### One of the following ID is required:

- Valid AZ Drivers License (number only) or non-operating ID number issued after October 1996
- Birth Certificate (legible copy)
- US Naturalization document (legible copy)
- Your US Passport (legible copy)
- Tribal Member documentation (legible copy)
