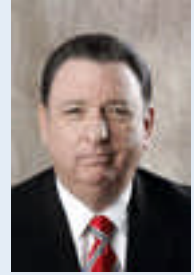

## **"In Defense of Ethnic Studies: Running for Our Lives"**

Dr. Rodriguez, the speaker at this year's annual meeting, is a longtime-award winning journalist/columnist who returned to school in 2003 in pursuit of a Master's degree and a PhD in Communications at the University of Wisconsin. Many of his awards and recognition have come about in the area of defense of the 1st Amendment and human rights.

His research on journalism has also resulted in the creation of

classes and exhibits at the UofA. He is the author of several books and has a forthcoming creation story that has been translated into 8 languages, a play and a dance "Quetzalcoatl, The Ants & The Gift of Maiz: a 7,000 year-old Ceremonial Discourse."

He was first nationally syndicated by Chronicle Features, then Universal Press Syndicate. Today, he writes for New America Media.

# LWVUS PUBLIC ADVOCACY FOR VOTER PROTECTION PROJECT: MORE THAN VOTER PROTECTION

In 2002, in the wake of the 2000 election, Congress passed the Help America Vote Act ("HAVA") to modernize the nation's election processes and to help ensure that eligible votes are no longer deprived of the franchise due to administrative errors.

In many states, politicians have seized on this opportunity as a means of disenfranchising targeted voters through changes in election laws. These new measures have the potential of disenfranchising more Americans than any Election Day problems we have seen in the past.

In an effort to fight back, the LWV PAVP project was launched in 2006. The project focuses on five specific issues areas. The project started with 6 states and has expanded to 15 states, including Arizona.

The project has provided pass through funding to help Leagues strengthen their advocacy capacity and develop and implement plans related to the issue areas. In addition to this funding, the PAVP project has provided full funding for the cost of state leagues Cap Wiz program and now the SALSA programs - an online advocacy tool, totaling over \$69,000.

State League members Kate Samsa and Barbara Klein, LWV/MP, are working on this project and have just put in an application for more grant money. Gini McGirr, LWV/GT, is taking webinar sessions on the SALSA website.

# LEGISLATIVE UPDATE

As this report is written on the 62nd day of the session, bills are being passed and sent to the governor. The House passed all bills in the Budget and the Senate still has HCR 2002 to discuss in committee. This is the one that will go on the ballot to transfer the balance of the Land Conservation Fund to the General Fund. This is a voter protected fund so it has to go to the voters, as does the one that will sweep the money from the First Things First voter protected fund. This is the cigarette tax proposition that goes towards children's education.

An Action Alert was sent out on SCR 1009 which prohibits taxpayer money from being used to fund candidates. It was written so that voters do not know when it will end Clean Elections as it does not mention Clean Elections in the bill. It has passed the Senate and is in the House. There is still time to write your legislators to tell them how to vote on this bill.

Several bills have come up on Term limits but none have passed yet. Other bills on Clean Elections and Merit selection have gone nowhere, but nothing is certain as any bill can become a "strike everything" bill and show up on some bill that has gotten half way through the Houses. One "striker" bill has brought the Payday Loans back to life. HB2370 which was originally Theft: Merchandise pallets and is now a bill to bring back Payday loans.

As you have read, the legislators spent a lot of time on bills for a state horse, state drink, state nick-name, presidential birth certificates, state Boy Scout day and Boy Scouts fishing licenses, human cloning, adoptions, divorces, etc.

It looks like there could be a lot of propositions on the ballot this year as the legislators will let the people decide.

## MEMBER GETS LONG-OVERDUE RECOGNITION

The Women Airforce Service Pilots, the first females in history to fly American warplanes, were awarded a Congressional Gold Medal for breaking barriers during World War II, when they were called upon to fill in on the home front for male pilots serving overseas.

League member Jane Carter and three other local women were recognized for their service as WASPs.

U.S. Rep. Gabrielle Giffords of Tucson called the gold medal - the highest civilian award given by Congress - "an honor that is long overdue."

## 90 Years of Making Democracy Work Did you know?

Ninety years ago, Carrie Chapman Catt first proposed a League of Women Voters to "finish the fight" and work to end all discrimination against women, and the League of Women Voters was founded on Valentine's Day in 1920. In its very first decade, the League established itself in public policy advocacy, helping to pass legislation providing federal aid for maternal and child care programs (Sheppard Towner Act), and working on the enactment of the Social Security and Food and Drug Acts.

The League also set up classes to train volunteer teachers for citizenship schools. And the League organized institutes to study defects in our system of government, initiated "Know Your Town" surveys, candidate questionnaires and meetings, and nationwide get-out-the-vote campaigns activities. In 1928 the League sponsored "Meet the Candidates," the first national radio broadcast of a candidate forum.

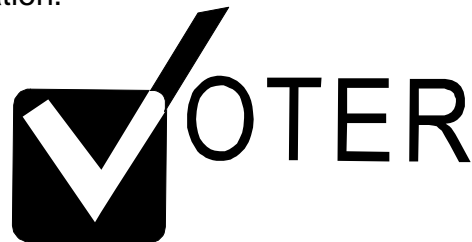
## Eastside Unit, Tuesday, May 4, 2010 at 9:30 am
