I am pleased that LWVGT was selected to participate in an LWVUS grant to support a high school voter registration project. Our voter service chair, Victor Bowleg, is in charge of this endeavor. If you are interested in helping, please call Victor at 401-2024.

The goal is to engage minority youth in the democratic process because almost half of all 18 year old U.S. citizens are still not registered to vote. Through specific activities, the entire senior class of each selected school will have the opportunity to register to vote. Findings will be utilized to develop some improved voter registration practices for local Leagues nation-wide.

Please join us for any or all of our LWVGT activities. We hope that you will bring your friends and neighbors to our monthly general meetings. We welcome guests. And we hope they will become members.

## Endowment Fund

After more than a year of investigation, discussions and consultation with CPAs and attorneys, LWVGT is placing the Harvey and Evelyn Lance Endowment monies with the Jewish Community Foundation of Southern Arizona (JCF). This agreement begins "The JCF hereby establishes a fund to be known as the "LEAGUE OF WOMEN VOTERS OF GREATER TUCSON ENDOWMENT FUND" ("FUND"), which shall be a perpetual endowment fund." There will be a yearly distribution from the fund to LWVGT through the LWVAZ Education Fund, as these funds must be used for educational purposes. In the future the LWVGT members will receive a report on how these funds will be used. Additional funds can be contributed to this fund and will be tax deductible for the donors. The committee determined that it is not feasible to set up our own "foundation and endowment fund" due to legal costs, brokerage costs, etc. and we have to follow Arizona law that regulates donated funds that are designated "endowment money".

Carol West, LWVGT President, and Phylis Carnahan, LWVGT Treasurer signed this agreement on July 16th, 2010 with the Jewish Community Foundation of Southern Arizona Executive Director Carol Karsch.

LWVGT first received a distribution from the Lance executor July 31, 2007 and the last distribution was on July 30, 2009 with a total to date of \$72,940. There is a possibility of a

future small distribution from property to be sold. LWVGT receives five percent of his estate. To date \$61,340 of the total that was originally placed in the Education Fund has been moved to the endowment fund. The balance of \$11,600 will be moved to the endowment fund when the Certificate of Deposit matures on January 13, 2011

LWVGT received *pro bono* legal advice from Sally J. Simpson, Simpson Law Office and information from Jane Espinoza, Controller, Jewish Community Foundation of Southern Arizona. The committee members greatly appreciated their willingness to answer many questions.

## UPDATE ON NEW AND OLD STUDIES

At the LWVUS convention in June, two new studies were adopted for the next two years, although it depends on funding and committee and staff time.

The recommended study was on "Federal Role in Public Education. Seventy one (71) Leagues recommended this study. This would focus on the role of the federal government in education policymaking, with possible consideration of funding, common standards and/or governance relationships among all levels of government. Hopefully, it will consider civic courses.

A non-recommended study was adopted by the delegates from the floor on Privatization: the policy agenda to transfer government functions, services and assets to the private sector. (We know here in Arizona about private prisons)

Committee members will be picked from members across the country to work on these programs.

The LWV/AZ study on The Structure of the Executive Branch of State Government in Arizona. This was adopted at the 2009 state convention. A Committee has been working on this study and has come up with some background material that will be sent to the local Leagues for a study meeting and will have the consensus questions. If possible, this could be done by the 2011 convention.

Since this is a study of a Lt. Governor, it is a timely subject as this is on the Nov. 2<sup>nd</sup> election ballot. But what ever comes out of the election, we will still need to have a position on this.

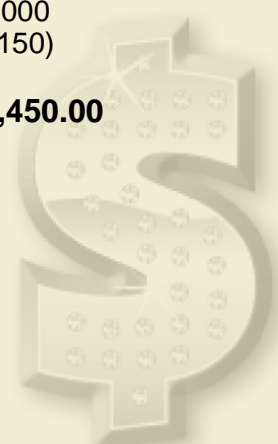

## CHARTER SCHOOLS

Charter schools were created in 1994 to (1) improve student learning and (2) provide parents a choice. It was also to bring innovation to the schools. Each charter school has its own mission or focus. Most focus on academics although some focus on other things such as basics, fine arts, performing arts, math or science. Some are programs for at risk students.

Charters for these schools may be obtained in one of three ways; through local school boards, by the State Board of Education or the State Board for Charter Schools. Charters in Arizona are granted for 15 years. They are supposed to be reviewed every five years and monitored regularly by the sponsoring board. From the very beginning of charter schools, the league has been in favor of more oversight and also for shorter charters.

Charter schools are not subject to many of the same regulations as the traditional public schools. The reasoning here is that it will make the schools shift from a rule-based to a performance-based system. Charter

schools must, however, be in compliance with the federal, state and local laws, rules, regulations and statutes relating to health, safety, civil rights and insurance.

Charter school teachers do not have to be certified. They are supposed to be "highly qualified" in the areas that they teach. This is highly subjective. It also means that they have not been trained at colleges of education where they would study how to teach. The schools are required to publish information on the qualifications of their teaching staff. Parents can check these out. Teachers are required to have background checks and fingerprints taken. Special education programs must be supervised by a certified teacher.

Charter schools do not have the same requirements for land and space. They are located in places where the traditional public schools could never be located, such as in storefronts and in industrial and commercial areas.
